I. After withdrawing from the bombers at the Dutch Coast, we made a 180° and went back over the continent to strafe. We hit the deck in vicinity of Zwolle made attack on trains and claim the following:

- One (1) Locomotive Destroyed - Lts. Moncrieff, Hairston.
- One (1) Locomotive Destroyed - Capt. Williams & Lt. Hendricks.
- One (1) Locomotive Destroyed - Capt. Morris & Lt. Perra.
- One (1) Flak Car Damaged @ Lt. Col. Johnson.

White Flt withdrew from area support nr Tours and hit deck. White Flt shot up three trucks camouflaged with branches on the top. All were burning when Flt left. Lt Clark and Lt MacArthur Dest two trucks in vic of Evreux. Red Flt shot up flak positions in area around Dreux claiming six flak towers Dam.
